Submission of Data under EnSure – Clarification

Name of the Return - Mission: RuPay Kisan Cards

Frequency – Daily

Please refer to our Circular No. 04 dated 09 Jan 2017 & Circular No. 07 and 08 dated 13 Jan 2017 on submission of data under EnSure. It has been observed that due to lack of uniformity of understanding across banks, the data being reported under RKCC issued is not getting reported properly. In this connection, we would like to clarify the following:

S.No	Column Heading	Clarification
1	Number of RuPay Kisan Cards Issued	This refers to the number of total cards issued to farmers by the bank in the system, which includes cards lying with the branch or in transit meant for delivery to KCC account holders, with effect from 1 st Jan 2017. Cards which are part of new a/c opening kit lying with the branch should not be taken as cards issued.

2	Number of RuPay Kisan Cards and PIN delivered	This refers to the cards which have been delivered to the customer along with PINs. Thus there may be a situation where number of cards issued is less than the number of cards and PIN delivered because the cards delivered on or after 1 st Jan 2017 may include cards issued prior to 31 st Dec 2016.

You are requested to fill the returns accordingly on daily basis.

Keeping in view the above clarifications you are advised to examine the data already uploaded on our ENSURE portal and take corrective actions, if necessary
