Individual Entrepreneurs are eligible to avail loan from NABARD under Warehouse Infrastructure Fund (WIF), for Projects with minimum aggregate storage capacity of 5000 MT and above.  NABARD does not provide loans directly to individual farmer for construction of Rural godown except to large storage infrastructures exceeding 5000MT. However, NABARD is channelizing subsidy on behalf of GoI under AMI sub scheme of ISAM when loans have been sanctioned/granted by Banks/ financial institutions (FIs) for godown of 50 MT or more.  There is no fund available under WIF for fresh sanctions. In view of this the applicant may submit his application to the local banks for credit support.
