Annexure II

Policy for Procurement of Goods, Services and Works -2023

Procurement - Goods & Services on Nomination basis:

- 3.9.1 The reasons for procurement on nomination basis detailed below at Sr. No.(i) to (xii) shall be recorded and approval of Competent Authority obtained on file.
 - Procurement of Goods and Services on nomination basis shall be under following circumstances:
 - i. It is in the knowledge of the Bank that only a particular firm is the manufacturer /supplier of the required goods and services.
 - ii. In a case of natural calamities/ other emergencies. The reason for such decision shall be recorded and approval of competent authority obtained.
 - iii. For procuring machinery or spare parts, technology, or services compatible to the existing sets of equipment, services. This decision shall be on the advice of a technical expert and the reason for such decision shall be recorded and approval of competent authority obtained. This provision shall also be applicable for equipment's such as water purifiers, kitchen chimney, air-conditioners etc., to obviate the need of multiple AMCs.
 - iv. the critical infrastructure already set up by the Bank needs to be maintained on a continuous basis for ensuring business continuity and timely disaster recovery for IT related hardware, software, and services from existing vendors.
 - v. product enhancement or up gradation of hardware and software from existing vendors for enterprise or critical applications like HRMS, CLMAS, ENSURE, ECM, RCSA, ERMS etc., for business continuity;
 - vi. engagement of specialised and critical services if limited tender process fails;
 - vii. acquiring of a niche IT product for enhancing IT capability of the Bank;
 - viii. In case of failure of an RFP to get even two quotations for goods and services including that of IT products and services through limited / open tender route, the lone bid received shall be accepted on nomination basis provided other efforts like extension of date and retendering with wider publicity fail to invite new bids.
 - ix. tasks that represent a natural continuation of previous work carried out by the firm;
 - x. situations where execution of the assignment may involve use of proprietary techniques or only one consultant has requisite expertise;
 - xi. Should it become necessary, in an exceptional situation to procure a non-consulting service from a specifically chosen vendor, the Competent Authority may do so in consultation with the CGM, ID, HO;
 - xii. hiring agencies which are subsidiaries of or set up by GoI/ RBI/ NABARD/ Regulatory Institutions/ Autonomous Bodies / institutions enacted by an Act of Parliament.
