Further Manufactures of Chairs should have Greenguard Certification (UL) i.e. interior products and materials that have low chemical emissions, improving the quality of the air in which the products are used. The bidder, who has qualified for Technical specification and L1 in the financial bid, has to bring sample chairs (as per the technical specifications mentioned in the tender) to office premises and place before the Committee constituted for the purpose. Committee has the final authority to accept or reject the order.

All other terms and conditions of the Tender Documents remain unchanged.
