- 1) NABARD intends to get the captioned work in Staff Quarters located at Sector-A &C, Shahpura, Bhopal and invites you to submit your tender for the same. The Tender Document is enclosed.
- 2) The tender document is available at NABARD's website and can be downloaded by the bidders from our website-www.nabard.org/tenders. Hard copy of the same may be obtained at the cost of Rs.500/- (per set) from DPSP, 3rd floor, NABARD, M P Regional Office, Ravishankar Nagar PO, E-5, Arera Colony, Bhopal-462016.
- 3) The intending bidder should be capable of supplying of above material as stated above. Bidder has also to submit the certificate from Original Equipment Manufacturer (OEM). Copies of GST registration certificate and work orders of previous work done of similar nature to NABARD.
- 4) The bidder is requested to clearly mention the make and model number of the quoted product and shall enclose a copy of brochure or actual sample piece for LED lights fixtures of items quoted in the technical bid (Part-1) of tender document.
- 5) The tenderers are advised to visit the site, conduct survey of the existing site conditions so as to familiarise themselves with the nature of works to be carried out and get all clarifications as necessary from NABARD before quoting their rates.
- 6) Each tenderer have two sets of Tender Document containing Part-1, comprising Notice Inviting Tender, Instruction to Bidders, General conditions of Contract, Safety Code and Special conditions of Contract, Technical specifications and Part-2 comprising Schedule of Quantities.
- 7) The eligible interested bidders are requested to submit their offer in two sealed separate envelopes in the prescribed Tender Document should be addressed to The Chief General Manager, National Bank for Agriculture and Rural Development (NABARD), MP Regional Office, Ravishankar Nagar PO, E-5, Arera Colony, Bhopal-462016 and the envelop should be super-scribed " Supply, Installation and Commissioning of various LED Lights fixtures in NABARD Staff Quarters located at Sector-A &C, Shahpura , Bhopal".

- 8) Envelope No. 1 shall contain Part I (Technical Bid) comprising of NIT, Form of tender (Declaration by bidder), Pre-qualification criterion, General Instructions to contractors and General Conditions, Technical Specifications, Scope of Work, certificate from Original Equipment Manufacturer (OEM). Copies of GST registration certificate and work orders of previous work done of similar nature to NABARD, Technical data sheet to be filled up for indicating the Makes & Specifications of items and EMD of stipulated amount.
- 9) Envelope No. 2 shall contain Part II (Price Bid) comprising of Bill of Quantities duly priced completed in all respects. This shall not include any conditions whatsoever. In case any conditions are included in Envelope No. 2, the same shall not be taken into consideration and the tender in such case is liable to be rejected.
- 10) The tenderer shall enclose a demand draft amounting to Rs. 12,800/- (Rs. Twelve Thousand and Eight Hundred only) drawn on any nationalized /scheduled bank payable at Bhopal in favour of NABARD towards Earnest Money Deposit(EMD) with envelop-1(Technical bid) of tender document, failing which tender shall be rejected. The EMD shall not bear any interest.
- 11) The technical bid (Part-1) and financial bid(Part-2) should be sealed by the bidder in separate covers duly super scribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly super scribed, completed in all respects duly signed by the tenderer, should be dropped inside the Tender Box available in DPSP, third floor, NABARD, M P Regional Office Bhopal, on or before 03.00 PM on 22 February 2019 and late tenders shall not be accepted. The Envelope I of tender will be opened on same day i.e. 22 February 2019 at 4.00 PM in the presence of the bidders or their authorised representative, who choose to be present.
- 12) After opening of the Envelope No. 1 and verifying the eligibility of the bidders and after assessing the conditions stipulated by bidders, if any, and evaluating the technical data sheet, the Bank will, if it so decides, may inform all the tenderers about any modifications in the tender conditions. In case there is no need for any change in the condition of tender, the envelope no. 2 will also be opened on the same day in the presence of bidders who choose to remain present, otherwise bidders who agree to the changed conditions along with the original in TOTO will be allowed to make modifications if they so wish in their tender prices by means of a letter to be submitted in sealed cover, which, along with their price bid will form the final price bid. A tender will be rejected if any tenderer proposes any deviation from the above.
- 13) The bidder should quote for all the sections of the tender/price bid. The Envelope No. 2 shall be opened only in respect of those eligible bidders who after discussion bring their tenders in line with the requirements of tender document and are, acceptable to the Employer. The decision of the Employer in this regard shall be binding on the bidders and not open to question or appeals. The date and time of opening of Envelope No. 2 shall be intimated after opening of Envelope No. 1.
