Tender for Annual Maintenance contract for providing "Security Services of Unarmed Security Guards at the NABARD Karnataka Regional Office and staff Quarters for the financial years 2025-26 & 2026-27."

National Bank for Agriculture and Rural Development (NABARD) invites tender in two parts from all eligible bidders for the captioned Annual Maintenance Contract works, as per the terms and conditions contained in the tender.

- 2. The tender will be available to the bidders/contractors for download from 10:00 hrs on 07.11.2024. Tender document may also be downloaded from NABARD's website: www.nabard.org as well as from the Central Public Procurement Portal (https://eprocure.gov.in)
- 3. The bidder shall submit two separate bids for the work- Technical bid and Price/Financial bid in separate sealed envelopes superscripted as Technical Bid and Financial Bid respectively. Tenders may be submitted to not later than 14:00 hrs on 29.11. 2024. Technical bids shall be opened on 15:00 hrs on 29.11.2024 at the Office of Chief General Manager, NABARD Karnataka Regional Office, Bengaluru-560009.
- 4. The Financial Bid shall be opened at a later date after detailed evaluation of the technical bid. The date of opening of Financial Bid shall be intimated separately to the technically qualified bidders only.
- 5. Instructions regarding Technical Bid, Financial Bid submission process and description & scope of work and the services required have been elaborated in the Terms and Conditions of the tender and other parts of the tender document.
- 6. It must be noted that the only Bidders who are willing to enter into Integrity Pact (IP) with the Bank on every stage of bidding, will be eligible to participate in the bidding process. Tenderer must implement Integrity Pact (IP) in the prescribed format in all phases of the contract. (http://www.cvc.nic.in)
- 7. **Earnest Money Deposit:** All bidders are required to deposit Earnest Money Deposit of Rs. 3,00,000/-, through **online** fund transfer only, in favour of NABARD as per the details given below:

The documentary proof of the same shall be enclosed.

- 8. The Financial Bid should not contain any conditions whatsoever and any such conditional bids received shall be rejected.
- 9. NABARD does not bind itself to accept the lowest bid (L1).
- 10. The decision of the bank shall be final and binding with regard to Technical and Financial bids and the tendering process.
- 11. The tender will be rejected, if any bidder proposes any deviation from the prescribed technical criteria requirement.
- 12. The bids shall remain valid and open for acceptance for 3 months from the date of opening of price/ financial bid.
- 13. All documents that comprise the offer should be signed and sealed by the firm, as a token of acceptance to the terms and conditions specified in the tender.
- 14. NABARD reserves the right to accept or reject any /all tender/s in part or whole of any firm / firms without assigning any reasons whatsoever. The decision of the Bank in this regard shall be final. In the event of intending tenderers failure to satisfy the bank, the bank reserves the right to reject the tender.
- 15. NABARD reserves right to change/modify/amend any or all provisions of the tender document. Such revision/amendment or corrigendum/addendum, if any, will be made available on NABARD's e-Procurement portal and NABARD's website only.
