The tenders shall be submitted in 'Original' to the Bank.

3. The sealed Tenders shall be opened at 15:30 hours on 22 March 2017 in the presence of bidders / their authorized representatives, who choose to be present.

The bids shall be accepted only in respect of those bidders whose tenders are in line with the requirements as per NIT, terms and conditions of the tender document and if the same is acceptable to the Employer. The decision of the Employer in this regard shall be binding on the bidders and not open to question or appeals.
