The clarifications given in pre bid meeting will also form part of tender document and will be uploaded on the website. NABARD reserves the right to revise the Price Bid after pre-bid meeting, if required, and same will be uploaded on website.

9. Contractors/firms are advised to ensure strict observance of technical and commercial aspects as indicated in the tender and sign on all pages as token of acceptance. The rate quoted shall be inclusive of all expenditure related to successful completion of work as per scope of work and tender conditions including all taxes except GST. Applicable GST shall be indicated separately as per the format of price bid and shall be paid for accordingly.
