

Proceedings of the Pre-Bid meeting held on 10 September 2020

Tender For Designing, Supplying, Fabricating and Erecting of Toughened Glass for Entrance Canopy and External Wall Façade at NABARD Regional Office, Bengaluru

Pre-bid meeting for the captioned project was held at NABARD, Karnataka Regional Office, 46, Kempe Gowda Road, Bengaluru at 11.30 am on 10 September 2020. Shri Meghal S Karekar, Consultant and representative of 01 contractor were present during the meeting along with NABARD officials. The issues discussed in the meeting and clarification to issues are given under:

S. No.	Point discussed	NABARD's Clarification
1	Additional item of work-MS structural steel additional members to the existing structural frame of the canopy of the side entrance	It is clarified that one additional item (Item No.8) for the work has been included in the Bill of Quantities (BoQ) for the work. Accordingly, the revised BoQ has been incorporated in the price bid for the work and is published in NABARD website. The intending contractors/firms are advised to submit the revised price bid for the work.
2	Buy back cost of materials removed and taken away	It is clarified that the contractor has to take away all the old materials from site which are removed while carrying out the work. The discount towards the buyback cost of the materials may be considered while quoting rates of the items in the price bid.
3	Die penetration tests for the welds	It is clarified that the Die penetration test for the welds to be carried out as per standard BIS codes and necessary rectifications/rework to be done by the contractor as part of the work at no additional cost i.e. the cost towards the same may be considered while quoting rates for the items in the price bid.
4	Cost of testing of materials	It is clarified that cost of testing of all materials to be included in the quoted rates and all test certificates to be submitted to NABARD.

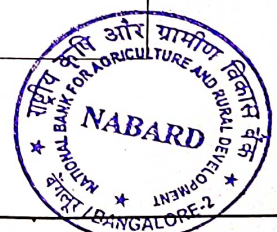

5	Dismantled glass and other debris of work	It is clarified that all the dismantled glass and other scrap materials/debris of work to be taken away from the site by the contractor. The cost towards the same may be considered while quoting rates for the items.
6	Drawings	An indicative drawing of the existing glass canopy is uploaded on the website for better understanding of the work by the bidders.

There are no other changes in the captioned tender. The contractors are advised to submit the pre-bid clarifications duly signed along with technical bid. The contractors are also advised to ignore the previous 'Price Bid' and submit the 'Revised Price Bid' for the work which is uploaded in NABARD website.
