

## Corrigendum to the Limited RFP for Establishing Software Factory for NABARD

1. The last date and time for bid submission has been extended to 25 April 2024 till 03:00 PM
2. The bid opening date has been revised to 26 April 2024 at 03:00 PM.
3. There has been addition/ deletion/ modification to certain clauses of the RFP. The changes are as follows:

4. Regarding the revised BOQ form for the commercial evaluation, the following may be noted:
  - All the licenses mentioned in the BOQ should include deployment in both DC and DR setup, which may be required for NABARD and its subsidiaries.
  - The Bidder has to provide for all DB licenses. If spare capacity for any kind of licenses is available with the Bank, it will be reduced later from the Bills of Material and NABARD will provide for the same.
  - Software including DB or any other component should have respective OEM Support/Enterprise Support and should also comply with the licensing policy of the OEM(s).
  - Free access to components/connectors should be provided by the LCAP and no additional cost be added for the same
  - Additional licenses/ manpower should be provided at the same unit cost on pro-rata basis as quoted in the BOQ during the entire contract period
  - The Bidder will extend additional training services, if required by the Bank, anytime during the contract period at the unit rate mentioned above for respective type of training. The bank will make additional payment at the unit rate quoted by the bidder and finalized in the contract for respective type of additional trainings beyond the scope of this tender.
  - The training phase will begin at a later stage, say six months after the platform's commissioning and will be conducted in batches with the aim of training the citizen/business developers within the organization.
  
5. Regarding DevOps/Platform Engineer: Please note that the BOQ form lists the quantity for DevOps/Platform Engineer as 01 (one) to enable to enable unit cost entry. But, the total cost for DevOps/Platform Engineer shall be shown as 0 (zero), as we don't anticipate immediate requirement and won't include commercial evaluation. This has been done for price discovery for DevOps/Platform Engineer only so that NABARD can engage at the discovered rate later as and when required for the project.
