

Revised Order

**Subject: Revision of Central Sector Scheme "Capital Investment Subsidy for Construction/Renovation of Rural Godowns" for remaining period of 11<sup>th</sup> Plan - reg.**

In continuation of Department of Agriculture and Cooperation's earlier order of even number dated 20.10.2011, the undersigned is directed to revise the said order as under:

Existing Provisions of the Scheme	Revised Provisions of the Scheme
<p>Capital cost of the project for the purpose of subsidy :</p> <p>(a) For godowns up to 1000 tonnes capacity - Project cost as appraised by financing Bank or actual cost or Rs 2500/- per tonne of storage capacity, whichever is lower;</p> <p>(b) For godowns exceeding 1000 tonnes capacity - Project cost as appraised by Bank or actual cost or Rs 1875/- per tonne of storage capacity, whichever is lower. However, for godowns exceeding 10,000 tonnes capacity, the subsidy would be restricted to that admissible for capacity of 10,000 tonnes only;</p>	<p>(a) For godowns up to 1000 tonnes capacity - Project cost as appraised by financing Bank or actual cost or Rs. <b>3500/-</b> per MT of storage capacity, whichever is lower;</p> <p>(b) For godowns exceeding 1000 MT capacity - Project cost as appraised by Bank or actual cost or Rs. <b>3000/-</b> per MT of storage capacity, whichever is lower.</p> <p>For NE region/hilly areas, normative cost will be Rs.<b>4000/-</b> per MT or as appraised by bank/financial institution, whichever is lower irrespective of godown capacity.</p> <p>For godowns exceeding 30,000 MT capacity (25,000 MT for the NE States, Sikkim and hilly areas), the subsidy would be restricted to that admissible for capacity of <b>30,000</b> MT (<b>25,000</b> MT for NE States, Sikkim and hilly areas) only, excluding the cases of cooperatives.</p>

(c) For renovation of godowns by cooperatives with assistance from NCDC - project cost as appraised by Bank / NCDC or actual cost or Rs.625/- per tonne of storage capacity, whichever is lower.

(c) For renovation of godowns by cooperatives with assistance from NCDC - project cost as appraised by Bank/NCDC or actual cost or Rs.750 per MT of storage capacity, whichever is lower.

Ceiling on maximum subsidy

a) in case of 33.33% subsidy

(i) Maximum amount of the subsidy for North-eastern States, Sikkim and hilly areas = Rs. 3.333 crore.

(ii) Maximum amount of the subsidy for other than North-eastern States, Sikkim and hilly areas = Rs.3 crore.

b) Maximum amount of subsidy in case of 25% subsidy = Rs. 2.25 crore.

c) Maximum amount of subsidy in case of 15% subsidy = Rs. 1.35 crore.

2. The other details of date of applicability, etc. will remain same as given in the order dated 20.10.2011..

3. The above revision of the scheme may be brought to the notice of all concerned.
