Amendment in the Operational Guidelines and Constitution of Empowered Committee to examine and approve cases referred by NABARD under Rural Godown Scheme – regarding

The undersigned is directed to state that the Department of Agriculture & Cooperation, Ministry of Agriculture is implementing Central Sector Scheme "Capital Investment Subsidy for Construction/Renovation of Rural Godowns" through Directorate of Marketing & Inspection (DMI). In the recent past it was brought to the notice of DAC that cases were rendered ineligible under the scheme on account of minor shortage in the minimum percentage of term loan under the project. The issue has been examined in the Ministry and with the approval of Competent Authority, following amendments in the guidelines of the Scheme is made for cases sanctioned during 11th Five Year Plan till, implementation of amended provision:

"Provision of minimum percentage of term loan is waived subject to ensuring minimum prescribed percentage of owner's contribution and financial implication in terms of subsidy outgo remaining unchanged."

2. In order to examine and recommend cases where NABARD has rejected projects (sanctioned during 11th Five Year Plan till, implementation of amended provision) due to shortfall in minimum percentage of term loan, it has been further decided to constitute the following Empowered Committee in the Department of Agriculture and Cooperation (DAC), Ministry of Agriculture:

Terms of Reference: The Committee will consider each case referred to it by NABARD being found ineligible for subsidy under Rural Godown Scheme for falling short of prescribed term loan, and will examine such cases for recommending with reference to the revised norms as detailed above and refer the cases recommended for subsidy to Integrated Finance Division of DAC for approval.
