I. Extension of Critical Dates

II. Clarifications Issued on Queries Raised in Pre-Bid Meeting dated 01.01.2024

Query 01: What would be the duty hours of the cook (skilled) and cleaner cum helper (unskilled)? Whether they will be assigned work in the same time slot?

Response 01: The duties of the cook and cleaner would be assigned on split basis, through the successful tenderer on need basis.

Query 02: Who is responsible for the accommodation of the workers during off duty?

Response 02: The deployed workers shall make their own arrangements for themselves during off duty.

Query no: 03- Does the experience in similar work sought in Pre qualification Criteria include Housekeeping and Catering? Does the experience in the field of Catering only Count?

Response 03: According to the experience sought in Pre qualification Criteria, the Contractor shall indicate the experience with respect to Management and Housekeeping including Catering Services in VoF and guest houses.

Query no: 04- Who will arrange for the Materials required for the Daily Cleaning of VoF?

Response 04: The cost of ISI approved products of reputed brands for cleaning and housekeeping in VoF used by the contractor will be reimbursed on monthly basis on MRP of the items procured. The invoices/bills with respect to purchase of materials should be verified by Care Taker/authorised

NABARD Official.

Query no: 05- Who will be bear the cost of recharge of DTH Connections in VoF?

Response 05: As per clause 5i of Scope of Work under Housekeeping, the Agency shall take care of miscellaneous requirements like replacement of batteries for clocks, remote units of TVs, ACs, recharge of DTH Connections etc. provided in the VOF rooms and other places.

In this connection, it is being clarified that the cost of recharge of DTH Connections as also the cost of dry battery cells for remote units of TV/AC shall be reimbursed to the contractor by NABARD Uttar Pradesh Regional Office on monthly/quarterly basis.
